We appreciate this information is for initial planning purposes with division allocations at the discretion of the EDPL Executive. **In applying for the above team/s, it is agreed that players will be available to fill each team prior to the start of the playing season.**

Requirements that need to be met prior to affiliation being granted:

- A minimum of 3 tables are required in accordance with EDPL Constitution 3.3.
- Clubs wishing to apply for more than 2 teams must have a minimum of 6 tables for matches.
- Clubs must have their own constitution (a current copy to be supplied to EDPL), along with a bank account in the club's name, with a minimum of two signatures for cheques from a panel on not less than three signatories.
- Monthly bank statements are required at each EDPL meeting, including AGM.
- Clubs are required to be an "Incorporated Association" in accordance with Victorian State Law. Copy of Incorporation Certificate to be produced on request.
- Clubs are required to have an elected Committee with details of those persons being supplied to EDPL. New applicants must supply details with this application form. Existing clubs are to supply details no later than the first playing week of new Winter Season (preferred by end of February).
- Clubs will elect a delegate and a proxy delegate from their own elected committee who will represent their club at EDPL committee/delegate meetings, and be authorised to vote on their clubs behalf.
- Affiliated Clubs are bound by the Constitution and By-laws of the EDPL at all times.
- Clubs agree that the playing rules used are those set down in the EDPL Handbook.
- Clubs not complying with any of the above requirements at any time may see their affiliation revoked.
- These requirements along with the affiliation fee are subject to alteration at the next AGM.

The \$75.00 per team affiliation fee is payable at the same time this application form is lodged.

The Closing Date for Year 2012 Affiliation is Friday 25th November 2011.
